

From September 9-10, the [Steering Committee](#) and the Coalition staff met in Washington, D.C. On the first day, we met at The Wharf to board a boat with USGS and Maryland DNR for an electrofishing demonstration on [invasive Blue Catfish](#).

On day two, we met at the Reservoir Center for Water Solutions discussing our many successes in D.C., as well as ongoing challenges and future goals. We also explored the transition to a Land Use Workgroup, the results from the recent Coalition survey, and federal updates.

Bay Agreement Status

On September 1, we submitted our formal feedback to the [Chesapeake Bay Watershed Agreement draft](#). The 37 pages of feedback included several areas of concern, including: setting a standard deadline, inclusion of the TMDL, adding the ICC as a signatory, and many more mandatory topics and issues.

Thank you to everyone who put their time and effort into supporting our draft suggestions and the 91 organizations who signed on.
